Sealed bids for the Project known and identified as: "Florida City Community Redevelopment Agency (CRA) West-Northwest Area Roadway Improvements" will be received by the CRA, Attention: City Clerk, 404 West Palm Drive, Florida City, Florida 33034 until **1:45 p.m. local time December 2, 2011**. Any bid received after 1:45 p.m. shall not be considered. The bids will be publicly **opened and read aloud at 2.00 p.m., December 2, 2011**.

The project consists of reconstructing-grading the city roads in a Northwest sector of the City of Florida City, reworking the limerock base, repaving, constructing curb and gutter and drainage improvements as required. The improvements also include new concrete and asphalt access driveways, handicap ramps, concrete sidewalks (as required), and landscape improvements. NW 12 St will be realigned and reconstructed from NW 7 Ave to NW 8 Ave.

All bids must be submitted in sealed envelopes bearing on the outside the name of the Bidder, his address, the name of the project for which the bid is submitted, and the date of opening. No bidder may withdraw his bid within ninety (90) days after the date set for the opening hereof. A Bid Bond in the amount of 5% of the bid is required to be submitted with the bid. Upon award of the contract, Performance and Payment Bonds in the amount of 100% of the contract award amount shall be required.
