## 4) SITE PLAN SUBMITTAL:

Must include the following:

- A) Three (3) signed/sealed sets of site plan
- B) One (1) signed/sealed 11"X 17" site plan copy
- C) Landscape Plan
- D) Signage Plan (if applicable)
- E) Site Survey and/or Plat
- F) Building Elevations
- G) Letter of Intent/ Articles of Incorportation/ LLC for owners and notarized authorization letter from owner to applicant
- **5) FEES:**
- >Parcels less than 1.5 acres in size: \$750 plus \$115/unit (residential) or \$.30/square foot of interior space (non-residential)
- > Parcels 1.5 to 3 acres: \$1,200 plus \$135/acre and \$160/unit (residential) or \$.35/square foot of interior space (non-residential)
- > Parcels greater than 3 acres: \$2,000 plus \$190/acre and \$200/unit (residential) or \$.40/square foot of interior space
- > Note: For calculation of the interior space fee above for hotels, only the ground floor and 2nd floor are counted.

Fee includes two (2) rounds of Staff review and one (1) meeting with Applicant and/or Representative. Additional reviews will require an additional fee equal to ½ of original fee per extra review. Fee is due with application submittal. FEES ARE NON-REFUNDABLE. Form and all requested documents/fees must be completed/submitted to process this application.
