4. APPROVAL OF MINUTES

A Motion was made by Committee Member Lovett to approve the Charter Review Minutes of August 19, 2021. Seconded by Committee Member Thompson. All voted in favor. The Motion was carried.

5. PROPOSED CHARTER LANGUAGE

City Attorney reiterated the proposed charter language whereby the City of Florida City, City Commission desires to change its form of Government from a Strong Mayor form of Government to a City Manager form of Government. In order for this to occur, members of the electorate have to vote in favor of this.

Ms. Monestime went on to discuss what is presently in the City's Charter: Section 2.02- Powers and Duties of Mayor.

She then discussed the recommended Charter provision – Form of Government-"The City shall have a "Commission-Manager" form of government; which Manager shall be responsible to the Commission for the administration of all City affairs.

Proposed Language Change on file for the record.

The Proposed Ballot question informed of the Strong Mayor form of government. CHARTER REVIEW COMMITTEE METING MINUTES: WEDNESDAY, SEPTEMBER 15, 2021- 6:00 PM

Shall the City government change to a Commission-Manager form of government beginning 2026?

There was consternation when several members of the Committee realized the City Manager form of government was not going to come into effect until January 2026.

Committee Member Thompson "The people who vote in this election will have to wait until 2026 for a City Manager form of Government?"

Attorney Monestime responded in the affirmative.

"If Mayor does not win in this Biennial election, who will be mayor?

City Attorney: "Whoever wins will be Mayor for the next four years."

Regine Monestime, after a bit more discussion with the Committee members asked for approval from the Charter Review Committee, if the Committee Members saw it fit to place the recommended charter provision on the ballot for the 2022 biennial election.

Committee Members Thompson, Clayton and Lovett commended present Strong Mayor Otis Wallace on the excellent job he has done in the past and is still doing in the City.

"Very many projects/ developments have been brought into Florida City under the umbrella of Mayor Wallace. Not many individuals are as qualified and knowledgeable as he is. "— Committee Member Clayton

Committee Member Thompson stressed, once again the importance of "getting the word out" to Florida City residents about what is happening in the City and the upcoming elections. He wants a City where everyone is informed of what is happening.

6. BALLOT QUESTIONS

A Motion was made by Committee Member Lovett for approval of the proposed ballot question: "Shall the City government change to a Commission/City Manager form of government beginning 2026" to be placed on the ballot for Florida City's Biennial Election which occurs January 25, 2022. Seconded by Committee Member Clayton. All voted in favor. The Motion was carried.

Because the Charter Review Committee members were all in agreement with the above, City Attorney, Regine Monestime voiced that there was no need to hold any additional meeting of the Review Committee.
